


At the outset, the Secretary apprised the members of the committee that the case of the project proponent was earlier discussed in the 15th and 17th meeting. A presentation was also sought from the project proponent in 17th meeting held on 23.04.2013. In 17th meeting of SEAC, the committee had made some observations and recommended to seek information from the project proponent. SEAC vide its letter dated 01.05.2013 has asked the Project proponent for furnishing information which was also followed by reminders dated 10.06.2013, 20.06.2013 and 26.08.2013. But, no information has been furnished by the Project proponent till date even after a lapse of 5 ½ months.

As per the OM dated 30.10.2012 by the MoEF, New Delhi wherein it has been decided that

- i) All projects where additional information desired has not been submitted even after 6 months of the EAC meeting, should be delisted from the list of pending projects
- ii) For the projects pending between 3-6 months of the EAC meeting for want of information, reminder may be sent seeking information within a month. If the information is not received within this period, even these projects may be de-listed.












In view of the OM dated 30.10.2012 of MoEF, New Delhi, the SEAC unanimously recommended that a notice may be issued to the Project Proponent informing that the information asked vide committee's letter dated 01.05.2013 which was followed by reminder dated 10.06.2013, 20.06.2013 and 26.08.2013, has still not been furnished. In view of the directions, passed by the MoEF, New Delhi vide its OM dated 30.10.2012, a reminder in a shape of notice may be given to the Project proponent for furnishing the information within one month. In case no information is provided by project proponent, the Secretary, SEAC, Chandigarh may inform the project proponent that project stands delisted.
