The case was considered by EAC, Chandigarh in its Ist meeting held on 23.11.2011 wherein after going through the papers submitted by the proponent along with Form - I/IA, the EAC vide its letter dated 30.11.2011 has asked the proponent to furnish the information on the preliminary observations/deficiencies found in the Form - I/IA. The proponent has submitted its reply vide letter dated 19.12.2011 which after careful consideration, the following preliminary observations have again been made:-

1. It has observed that no detail of existing and proposed plantation has been

- Although the proponent claims to have approval from the Chief Fire Officer as regards provisions for the prescribed Fire Safety. No such approval was found in Annexure IV. The valid approval may be furnished.
- The matter regarding final disposal point of treated and untreated waste is not clear from the reply of the proponent. The proponent may be asked to clarify the same and necessary approval/concurrence from the authorities be submitted.
- 4. For the reasons of curtailing the delay in clearing the project on merits, while seeking clarifications on the preliminary objections/deficiencies in the proposal, EAC suggested the proponent to simultaneously make presentation of their project on 14.01.2012 at 10:00 A.M. in the Department of Botany, Panjab University, Chandigarh. The clarifications could be submitted before or even at the time of the presentation.
